In England and Wales, section 75(7) of the Social Security Administration (Fraud) act 1997, allows a Housing Benefit determination to be registered as an order of the Court. This method enables the Authority to issue enforcement proceedings against the debtor. The methods of enforcement are: a warrant of execution, which authorises a bailiff to seize goods an attachment of earnings; a garnishee order, which attaches a debt owed by a third party e.g. a bank account to the debtor charging order, which attaches a legal charge to immoveable property (e.g. a house) of the debtor
