Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

PROMOTION OF LICENSING OBJECTIVES:

- a. General:- All four licensing objectives: Both premises licence holders have over 5 years experience in the trade. Both attended and passed BII training course at Pembrokeshire College.
- b. Prevention of Crime and Disorder: The premises is secured by good quality locks. We will not serve anyone who appears under 18, we will ask for ID if in doubt. Drunken persons will not be permitted. Both licence holders fully cooperate with the Police and Local Authority Licensing Officers. The village is a law abiding area.
- **c. Public Safety:** Public liability insurance is in place. Fire extinguishers, first aid kit, emergency lighting. Signs are in place.
- **d. Prevention of Public Nuisance:** Disorderly conduct will not be allowed anyone acting in a disorderly manner will be asked to leave. Consideration for neighbours when music is played noise levels will be monitored and when necessary turned down.
- e. Protection of Children from Harm: Anyone who appears to be under 18 will not be served. No children will be employed behind the Bar. Children under 16 will always be accompanied by an adult. Children will not be permitted to remain on the premises after 10pm.
