### **Annex 1 - Mandatory conditions**

### Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

# Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
  - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
  - (b) in respect of premises in relation to—
    - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
  - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
  - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

### Annex 2 - Conditions consistent with the operating Schedule

- A) I believe it is important to preserve the quality and environment of my premises and the surrounding area.
- B) Be ensured that if need be I will report any crime or disorder immediately and feel it is important to maintain a good relationship with the local police. We have no tolerance to drunken and or inappropriate behaviour including violent or anti social and believe in promoting and encouraging a crime free and care free environment.
- C) I am committed to providing my customers and those around my premises with peace of mind, ensuring the area is kept clean and well lit and provide bins for litter disposal promoting health and safety guidelines. Also no customers are allowed behind the counter, the floor in the waiting area for the customers is a special non slip material and provided is a doormat for customers to wipe there feet at the entrance. Any spillages etc are cared for by staff immediately. We don't sell bottles all soft drinks are supplied in cans. There are two types of fire extinguishers one for the fryer and another for all other purposes, we also have a fire blanket, these are all inspected on an annual basis and we have certificates as proof of there inspection. The electricity is on a trip switch in case of an emergency also we have a torch at hand for such emergencies. The whole shop floor is on one level allowing easy access for disabled persons. All provided to ensure the health and safety of our customers.
- D) I intend to make staff aware of these policies and the importance of them and in prevention of public nuisance and to make it clear to customers if I feel person is acting in such a way I would ask that person to leave in calm and controlled manner.
- E) I take it as paramount importance to be aware of all that is in and around my premises and will contact police immediately if I feel that a child or young person was in danger or was drunken or age or if I saw any inappropriate behaviour.
