The Council proposes to make the Ceredigion County Council (Prohibition And Restriction Of Waiting And Loading And Unloading) Order 2019 (Aberystwyth Seafront) (Parking Places and Charges) (Amendment Order No. 13) 202x to introduce changes to parking restrictions detailed below.

2.	Victoria Terrace, northern end on landward side, from the existing Prohibition of Waiting At Any Time covering the turning area, southwards for a distance of 168m	New Prohibition of Waiting 8am-8pm replacing existing Prohibition of Waiting 9am-6pm.
3.	Victoria Terrace, landward side from southern end of above restriction, southwards for a distance of 35m	New Prohibition of Waiting at Any Time replacing existing Prohibition of Waiting 9am-6pm.
4.	Police Station Road northern side, from its junction with Victoria Terrace, eastwards for a distance of 8m	New Prohibition of Waiting at Any Time replacing existing Prohibition of Waiting 9am-6pm.
5.	Police Station Road northern side, from eastern end of the above restriction, eastwards for a distance of 14m	New Prohibition of Waiting 8am-8pm (no existing restriction) to meet western end of existing Prohibition of Waiting at any Time
6.	Police Station Road southern side, from its junction with Victoria Terrace, eastwards for a distance of 15m	New Prohibition of Waiting at Any Time replacing existing Prohibition of Waiting 9am-6pm. to meet western end existing Prohibition of Waiting At Any Time
7.	Victoria Terrace, landward side, from southern end of new Prohibition of Waiting at Any Time at location 3 above, southwards for a distance of 30m	New Prohibition of Waiting 8am-8pm replacing existing Prohibition of Waiting 9am-6pm.
8.	Victoria Terrace, landward side, from end of restriction at location 7, southwards for a distance of 4m	New Prohibition of Waiting at Any Time replacing existing Prohibition of Waiting 9am-6pm.
9.	Albert Place, northern side, from 8m eastwards of its junction with Victoria Terrace, eastwards for a distance of 20m	New Prohibition of Waiting at Any Time replacing existing Prohibition of Waiting 9am-6pm, to meet western end of existing Prohibition of Waiting At Any Time by junction with Queen's Road
10.	Queen's Avenue, northern side, from a point 27m eastwards of its junction with Queen's Road, eastwards for a distance of 31m	New Prohibition of Waiting at Any Time replacing existing Prohibition of Waiting 9am-6pm to meet existing Prohibition of Waiting At Any Time by junction with North Road
11.	Queen's Avenue, southern side from a point 10m eastwards of its junction with Queen's Road, eastwards for a distance of 47m	New Prohibition of Waiting at Any Time replacing existing Prohibition of Waiting 9am-6pm. to meet existing Prohibition of Waiting At Any Time by junction with North Road
12.	Marine Terrace, landward side from the existing Prohibition of Waiting by its junction with Albert Place, southwards for a distance of 5m	New Prohibition of Waiting at Any Time replacing existing Prohibition of Waiting 9am-6pm.
13.	Marine Terrace, seaward side from the existing Prohibition of Waiting at Any Time by its junction with Albert Place, southwards for a distance of 115m	New Pay and Display/Pay by Phone bay, 8am-8pm, 4 hours no return within 4 hours replacing existing Limited Waiting, Mon – Sat, 8am-6pm, 4 hours, no return within 4 hours.
14.	Marine Terrace, seaward side from southern end of previous restriction, southwards for a distance of 3m	New Prohibition of Waiting at Any Time to meet existing pedestrian crossing zig-zag markings.
15.	Marine Terrace, landward side from southern end of new Prohibition of Waiting at Any Time at location 12 above, southwards for a distance of 118m	New Prohibition of Waiting 8am-8pm replacing existing Prohibition of Waiting 9am-6pm to meet existing pedestrian crossing zig-zag markings.
16.	Marine Terrace, seaward side from the southern end of existing pedestrian crossing zig-zag markings, southwards for a distance of 106m	New Prohibition of Waiting at Any Time and Prohibition of Loading 10am-8pm replacing existing Prohibition of Waiting and Loading 10am-8pm and reducing that by 2m at northern end to meet existing pedestrian crossing zig-zag markings by junction with Terrace Road
17.	Marine Terrace, landward side from southern extent of existing pedestrian crossing zig-zag markings southwards for a distance of 16m	New Prohibition of Waiting 8am-8pm replacing existing Prohibition of Waiting 9am-6pm.
18.	Marine Terrace, landward side from southern end of restriction at location 17 above southwards for a distance of 90m –	New Pay and Display/Pay by Phone bay, 8am-8pm, 4 hours no return within 4 hours replacing existing Limited Waiting, 1st May – 30 Sept, Mon – Sat, 9am-6pm, 2 hours, no return within 2 hours.
19.	Marine Terrace, seaward side from 5m south-westwards of the centre of its junction with Terrace Road, south-westwards for a distance of 28m	New Tourist Bus Only bay, 8am-8pm, 15mins, no return within 1 hour replacing existing Tourist Bus Only bay, 1st Apr – 31st Oct, 9am – 6pm, 15mins, no return within 1 hour (co-ordinating with existing bay marking).

20.	Marine Terrace, landward side from southwestern end of the existing Prohibition of Waiting at any Time by its junction with Terrace Road, generally south-west for a distance of 53m	New Pay and Display/Pay by Phone bay, 8am-8pm, 4 hours no return within 4 hours replacing existing Limited Waiting, 9am-6pm, 1 hour, no return within 1 hour.
21.	Marine Terrace, seaward side from the end of the existing Tourist Bus Only bay marking (see location 19), southwest-wards for a distance of 43m	New Pay and Display/Pay by Phone bay, 8am-8pm, 4 hours no return within 4 hours replacing existing Limited Waiting, Mon-Sat, 8am-6pm, 4 hours, no return within 4 hours.
22.	Marine Terrace, seaward side from southwestern end of restriction at location 21, southwest-wards for a distance of 21m	New Disabled Badge Holders Only bay, 8am-8pm, 4 hours, no return within 4 hours replacing existing Disabled Badge Holders Only bay.
23.	Marine Terrace, seaward side from southwestern end of restriction at location 22, southwest-wards for a distance of 110m	New Pay and Display/Pay by Phone bay, 8am-8pm, 4 hours no return within 4 hours replacing existing Limited Waiting, Mon-Sat, 8am-6pm, 4 hours, no return within 4 hours
24.	Marine Terrace, landward side from end of existing Prohibition of Waiting at Any Time at boundary of number 8 and 9 Marine Terrace, southwest-wards for a distance of 50m	New Pay and Display/Pay by Phone bay, 8am-8pm, 4 hours no return within 4 hours replacing existing Limited Waiting, Mon-Sat, 8am-6pm, 1 hour, no return within 1 hour.
25.	Marine Terrace, landward side from southwestern end of restriction at location 24, southwest-wards to meet existing Prohibition of Waiting at Any Time by junction with Pier Street –	New Prohibition of Waiting at Any Time replacing existing Limited Waiting, Mon-Sat, 8am-6pm, 1 hour, no return within 1 hour.
26.	Laura Place, western side, from access to St Michael's Church southeast-wards for a distance of 6m	New Prohibition of Waiting at Any Time to co-ordinate with existing prohibition by northwestern side of the access
27.	King Street, landward side from western end of existing Prohibition of Waiting at Any Time by junction with Laura Place, southwest-wards for a distance of 109m –	New Pay and Display/ Pay by Phone bay, 8am-8pm, 4 hours no return within 4 hours, and Prohibition of Waiting for Caravans and Motor Caravans 11pm-8am replacing existing Limited Waiting, Mon-Sat, 8am-6pm, 2 hours, no return within 2 hours introduced by the Ceredigion County Council (Prohibition And Restriction Of Waiting And Loading And Unloading) Order 2019 (Aberystwyth Seafront) (Amendment Order No. 11) 2024)

New Promenade seaward side, from a point 69m westward of the centre point of its junction with Pier Street, southwest-wards for a distance of 55m	New Pay and Display/Pay by Phone bay, 8am-8pm, 4 hours no return within 4 hours, and Prohibition of Waiting for Caravans and Motor Caravans 11pm-8am replacing existing Limited Waiting, Mon-Sat, 8am-6pm, 4 hours, no return within 4 hours and Prohibition of Waiting for Caravans and Motor Caravans 11pm-8am introduced by the Ceredigion County Council (Prohibition And Restriction Of Waiting And Loading And Unloading) Order 2019 (Aberystwyth Seafront) (Amendment Order No. 11) 2024)

New Promenade seaward side, from a point 22m southwest-wards from the southwestern end of the restriction at location 29, southwest-wards for a distance of 90m	New Pay and Display/Pay by Phone bay, 8am-8pm, 4 hours no return within 4 hours and Prohibition of Waiting for Caravans and Motor Caravans 11pm-8am replacing existing Limited Waiting, Mon-Sat, 8am-6pm, 4 hours, no return within 4 hours and Prohibition of Waiting for Caravans and Motor Caravans 11pm-8am introduced by the Ceredigion County Council (Prohibition And Restriction Of Waiting And Loading And Unloading) Order 2019 (Aberystwyth Seafront) (Amendment Order No. 11) 2024)
