Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to-
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010

With effect from 6th April 2010

1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children –

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

(d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-

(i) the outcome of a race, competition or other event or

process, or

(ii) the likelihood of anything occurring or not occurring;

(e) selling or supplying alcohol in association with promotional

posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

With effect from 1st October 2010

4. (1) The premsies licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

5. The responsible person shall ensure that –

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is avilable to customers in the following measures –

(i) beer or cider: ¹/₂ pint

(ii) gin, rum, vodka or whisky: 25ml or 35ml; and

(iii) still wine in a glass: 125ml; and

(b) customers are made aware of the avilability of these measures.

The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2014

With effect from 28th May 2014

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1-
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1976(6);
 - (b) "permitted price" is the price found by applying the formula -

P = D + (DxV)where -(i) P is the per

- (i) P is the permitted price
- D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) The holder of the premises licence,
 - (ii) The designated premises supervisor (if any) in respect of such a licence, or
 - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1997(7)

- **3.** Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 - Conditions consistent with the operating Schedule

a) General

A large 10 acre field on the minor road from Penparc to Llangoedmor, securely fenced, mains water supplied and security gates on entrance to site. Camping will be allowed on site from Friday evening until midday Sunday. The main festival gates will be open from 11am on Saturday at which point the fair will be open and fete stalls and food and drink outlets. The main stage and local music stage will start approximately 1pm on Saturday until 1am Sunday morning. Alcohol will cease to be sold at 2am Sunday morning to allow people to relax before leaving the site to hopefully cause less of a public nuisance and minimise disturbance to local residents.

We aim to provide a secure environment for our guests to have a fun time and raise money for the Air Ambulance Service, a charity that has recently been brought to the hearts of many locals. To do this we intend to monitor staff levels in all areas accordingly, employing qualified doormen, bar staff, parking and camping attendants and local licensed food and soft drinks outlets, fun fair, trade stands, inflatable castles and music zones.

b) The prevention of crime and disorder

We aim to provide 1 SIA qualified person per 125 guests, alongside parking attendants, festival stewards and trained bar staff. All perimeter areas will be securely fenced, safety barriers will be positioned around beer tents, and music stages. There is good mobile phone signal on the site so these will be used as a point of contact along with relevant people carrying back up 'walkie talkies'. Wristbands will be issued on receipt of paperwork in the ticket office to allow people then to access main admission gates at which point there will be an appropriate building for stop and search facilities carried out on a sex on sex basis. We will also have stewards positioned to help crowd control and crowd flow.

c) Public safety

Car parking will be monitored by attendants along with the camping site. The children's areas will be on the edge of the licensed area for safety and securely monitored by security staff. The traffic will be turning mainly off the main A487 Cardigan to Aberystwyth Road. Caution signs will be positioned along this stretch of road and traffic will be kept flowing off the unclassified road. On leaving the site, traffic will be encouraged with signage to turn right and back to Cardigan via Llangoedmor so as to try and alleviate some traffic congestion. The site will have a comprehensive first aid area and an Information/Contact centre. Designated walkways will allow access to and from car parks and camping sites. Appropriate distance will be allocated between marquees to isolate and fire risks and appropriate fire equipment will be on site. All staff will be educated in fire procedures and health and safety issues. All electrical equipment will be installed and inspected by a qualified person prior to the site opening.

d) The prevention of public nuisance

Speakers and music equipment will be positioned facing east away from the few houses so as sound travels across the open space to limit the noise impact. Adequate signage and monitoring of roads to help alleviate congestion into the site and on the public highways. We have staggered closing times to 1am for music, 2am for alcohol and 3am for hot food and beverages to enable a more monitored and less noisy exit from the site. Camping has also been provided to try to help with the exit from the site and reduce the risk to anyone drink driving and noise control.

e) The protection of children from harm

Children's areas will be monitored well be security staff. Tickets will be booked on-line along with age verification processes we use with the Gambling Commission to verify anyone is over 18. Wristbands will be issued to all and children will have a different colour. Anyone not wearing a wristband will be removed from the area and no alcohol will be issued without a wristband. A "think 21" policy will be operational in the beer tents and a wristband is compulsory and anyone considered to be under 21 will be asked to produce ID to be served. Designated alcohol areas will be monitored at all times by stewards and anyone under 16 will not be allowed in these areas after midnight for any reason. Additional Information:

There will be a 3 metre roped off pathway from Front gates to the right of the main toilet area along outer fencing to accommodate campers walking to campsite and caravans and motor homes to enter and leave the site between Friday midday to 11.30pm and Saturday 8am to 3pm.
