5. XXXXXX died on 9th June 2013 [leaving no Will and no Letters of Administration were granted. XXXXXX had no surviving spouse or children. Under the rules of intestacy XXXXXX became the sole owner of the grave space and Exclusive Right of Burial Deed.] **OR** [leaving a Will dated XX and Probate was granted on XX, certified copies of the Will and Grant of Probate are attached to this declaration and marked 'Exhibit 2' and 'Exhibit 3'. In accordance with the terms of the Will XXXXXX became the sole owner of the grave space and Exclusive Right of Burial Deed.]
6. XXXXXX died on 25th August 2017 [leaving no Will and no Letters of Administration were granted. XXXXX had no surviving spouse and we are his only children. Under the rules of intestacy we are now the owners of the grave space and Exclusive Right of Burial Deed.] **OR** [leaving a Will dated XX and Probate was granted on XX, certified copies of the Will and Grant of Probate are attached to this declaration and marked 'Exhibit 2' and 'Exhibit 3'. In accordance with the terms of the Will we are now the owners of the grave space and Exclusive Right of Burial Deed.] XXXXX wish was to be buried with his parents in grave space 111, *Section 12 in New Quay Cemetery.*

7. And I make this solemn declaration conscientiously believing the same to be true and by virtue of the Statutory Declaration Act 1835 and hereby indemnify Ceredigion County Council against any error, mistake or falsehood.
