Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence—
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) “security activity” means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

- a. General – All four licensing objectives:- To monitor situations to encourage families and couples to enjoy the facilities by adhering strictly to times for opening by providing sufficient staff and training.
- b. Prevention of Crime and Disorder:- Prevention of drunkenness by being vigilant. Refusing entry to anyone who appears intoxicated and after 10.30pm in any event. Premises is secured by good quality locks.
- c. Public Safety:- Adhering to all Health and Safety standards and ensuring that the Cliff train will always be available until a period of 30 mins following the finish of the licensed period. Public Liability Insurance in force, we will advise our insurers of operating schedule. First aid kit available.
- d. Prevention of Public Nuisance:- Train/carriage capacity will be limited to 20 persons. Each journey is separated by a 15 minute interval. Therefore discharge of customers will be gradual. Premises is in an isolated location therefore noise pollution should not be a factor. Any external regulated entertainment will cease by 2200 Hrs.
- e. Protection of Children from Harm:- Staff are instructed not to serve alcohol to anyone who appears to be under 18, they will challenge anyone who appears to be under 21 and demand proof of identification. They will accept passport, computerised driving licence and PASS logoed ID cards. If in doubt they are instructed not to serve.

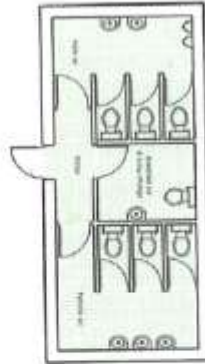
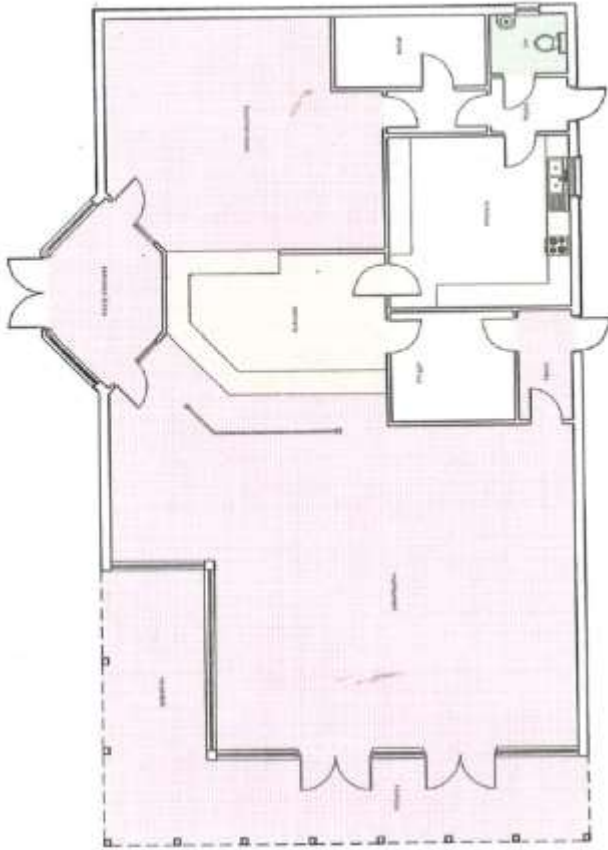
I would recommend:

- 1. At all times following functions involving amplified music beyond 2300 Hrs a member of staff accompanies passengers leaving the premises and reminding them to be quiet on leaving the lower station.**
- 2. Notices at both stations encouraging considerate behaviour on leaving the premises.**
- 3. A member of staff to accept any calls regarding nuisance occurring on the premises and to make written note of details. These to be kept in a logged book.**
- 4. All external doors and windows must be kept closed, other than for access and egress, in all rooms when events involving amplified music or amplified speech are taking place.**

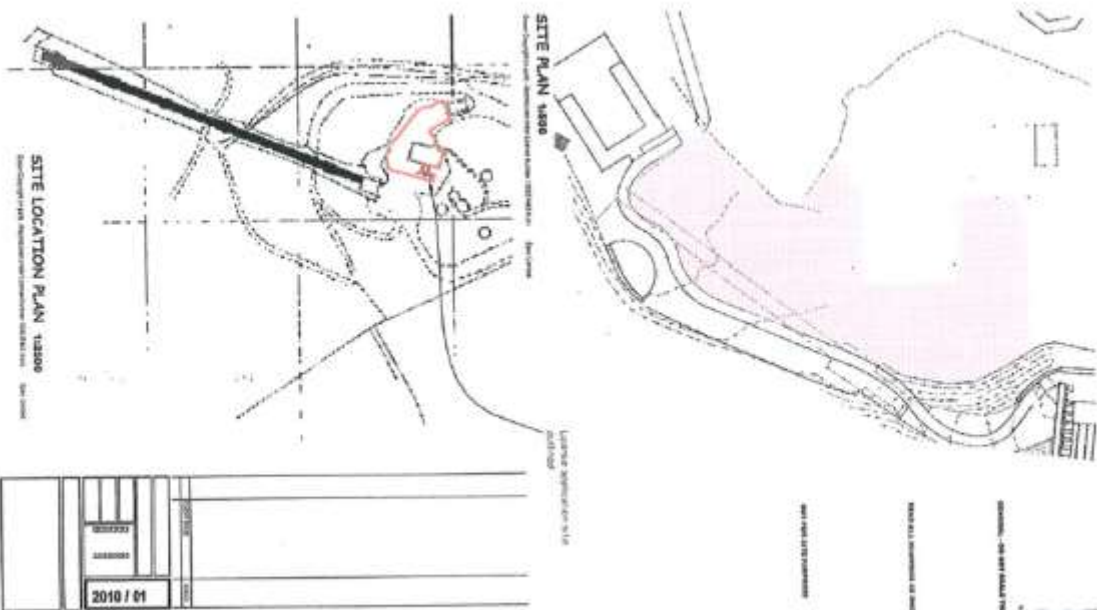
