Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

Promotion of Licensing Objectives:

a. General - All four licensing objectives

Users and hirers of the hall will be fully advised of the requirements of this operating schedule. They will sign a suitably worded document to confirm their understanding of the requirements.

b. Prevention of Crime and Disorder

The council will not permit disorderly behavior and hirers and users will be expected to agree and comply with the contract of hire.

c. Public Safety

Public Liability insurance is currently in being and we will inform our insurance company of this license, if it is granted. Fire equipment is currently installed (see plan). The hall has recently undergone refurbishment and all electrical and fire safety meets current legislation. A first aid kit is to be found on site.

d. Prevention of Public Nuisance

The hall is built in its own grounds. In the event of regulated entertainment, hirers will be instructed to close windows and doors, except for access. The council will vet applications for hiring and will not agree to allow activities to take place which would cause nuisance.

e. Protection of Children from Harm

Hirers will be reminded of their duty of care to children in their charge.
