Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence—
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) “security activity” means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

Premises subject to embedded conditions converted under Licensing Act 1964 except Section 68 (Supper Hour Certificate).

- a. General-all licensing objectives:- All staff are made aware of the requirements of the Licensing Act 2003 and have to comply with the relevant parts of the Act. The doors will be closed by midnight and no further customers will be admitted after that. There will be 30 minutes drinking up time for gradual departure from premises.**
- b. Prevention of Crime and Disorder:- Staff are required not to serve anyone who is drunk or behaving in an unacceptable manner. Toilet access is clear from the Bar. A taxi service is promoted to assist with onward journeys.**
- c. Public Safety:- The premises have been inspected by the Fire Authority and there are signs for fire exits. There are fire extinguishers and emergency lighting on the premises. Current electrical certificate in force. First aid box available.**
- d. Prevention of Public Nuisance:- Noise levels are monitored to avoid disturbance to neighbouring properties. Sale of alcohol is refused to anyone deemed to be under the influence. Patrons are required to leave quietly to avoid disturbing local residents.**
- e. Protection of Children from Harm:- Unaccompanied children are not permitted. Children are only allowed in the lounge/eating area and not in the bar. All staff are required to ask for proof of age whenever deemed necessary. There will be signs in the Bar prohibiting direct or indirect sale of alcohol to under 18's.**

Annex 3 - Conditions attached after a hearing by the licensing authority/Mediation Meeting.

Matters Agreed:

- **Remove Section 68 Licensing Act 1964 (Supper Hour Certificate).**
- **We will not allow drunken, violent and quarrelsome behaviour. Persons behaving as such will be asked to leave and if necessary the Police informed.**
- **Remove the offering under Prevention of Crime and Disorder that 2 people will be on duty on the Premises.**
- **CCTV to be installed inside and outside the premises by 10th March 2006. Footage to be kept for 30 days minimum.**
- **Signs asking customers to leave quietly. Persons who ignore requests will be banned from premises.**
- **Persons under 16 will only be allowed in the restaurant. No under 18's on premises after midnight.**
- **Hours adjusted Mon-Fri to 0100 Hrs. Opening hours on Sat to 0200 Hrs.**

2. **Major Live Sporting Events to Sell Alcohol 30 minutes before and after each event i.e. Olympic Games (Summer and Winter), Football World Cup, Rugby World Cup, World Championship Boxing, Cricket Test Matches and One Day Internationals, Golf Majors and Ryder Cup, Tennis Major Events, Athletics held in USA and Australia, Motor Racing Grand Prix (Cars and Motorcycles).**
