#### Annex 1 - Mandatory conditions

#### Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

#### Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
  - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
  - (b) in respect of premises in relation to-
    - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
  - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
  - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

# Annex 2 - Conditions consistent with the operating Schedule

### a) General – all four licensing objectives

Staff training – currently have 3 members working towards their NVQ Level 2. They have over 50 years retail experience between them.

There is ALWAYS at least one member of senior staff present throughout every day (with junior staff).

## b) The prevention of crime and disorder

I will not allow drunken, quarrelsome and disorderly behaviour. Anyone so behaving will be asked to leave and if necessary the police informed. Security:

- i) Locks all new and acceptable to NFU Insurance.
- ii) CCTV digital colour system downstairs and upstairs. Immediate copy to police. Currently 4 cameras
- iii) Cash tills all monies put away in safe at the end of every trading day.

## c) Public safety

Public liability insurance in force. Comprehensive first aid kits available. Exterior of premises is well lit. Emergency lighting fitted over exits. Premises is a new build and is currently up to standard. Health and Safety risk assessments are being prepared

### d) The prevention of public nuisance

Regulated entertainment will be ancillary to dining. Hours of operation will not be excessive. Musical events will be infrequent and for special occasions only. Signs will be displayed to advise customers to leave premises quietly. Doors and windows will be closed after 10pm when live and recorded music is played.

# e) The protection of children from harm

Staff have been instructed not to serve anyone who appears to be under 18 and to challenge 21 who attempt to purchase alcohol.

They will demand proof of identity i.e. computerised driving licence, Passport, valid cards and similar.

If in any doubt they are instructed not to serve.
