**Title:** Ceredigion County Council (Prohibition and Restriction of Waiting and Loading and Unloading) Order 2019 (Felinfach) (Amendment Order No. 12) 2024

**Purpose of the report:** To seek authorisation for the making of the above Traffic Regulation Order and the publication of a notice to that effect in local press.

## **Introduction**

It is necessary to introduce new parking restrictions on the A482 at Felinfach to facilitate safe access/egress by the new Aeron Valley Area school via a Traffic Regulation Order (TRO).

First and Second stage consultation on the proposed new restrictions has been completed and no objections were received.

Authorisation is now sought to proceed with the Making of the TRO and the publication of a Notice to that effect in local press. The coming into force date for the TRO will be agreed with the contractor so as to co-ordinate with completion of the necessary works prior to the opening of the new school.

New speed limit arrangements are also to be introduced by the new school and are being introduced via a separate TRO by the Service using delegated powers for the introduction of speed limits.

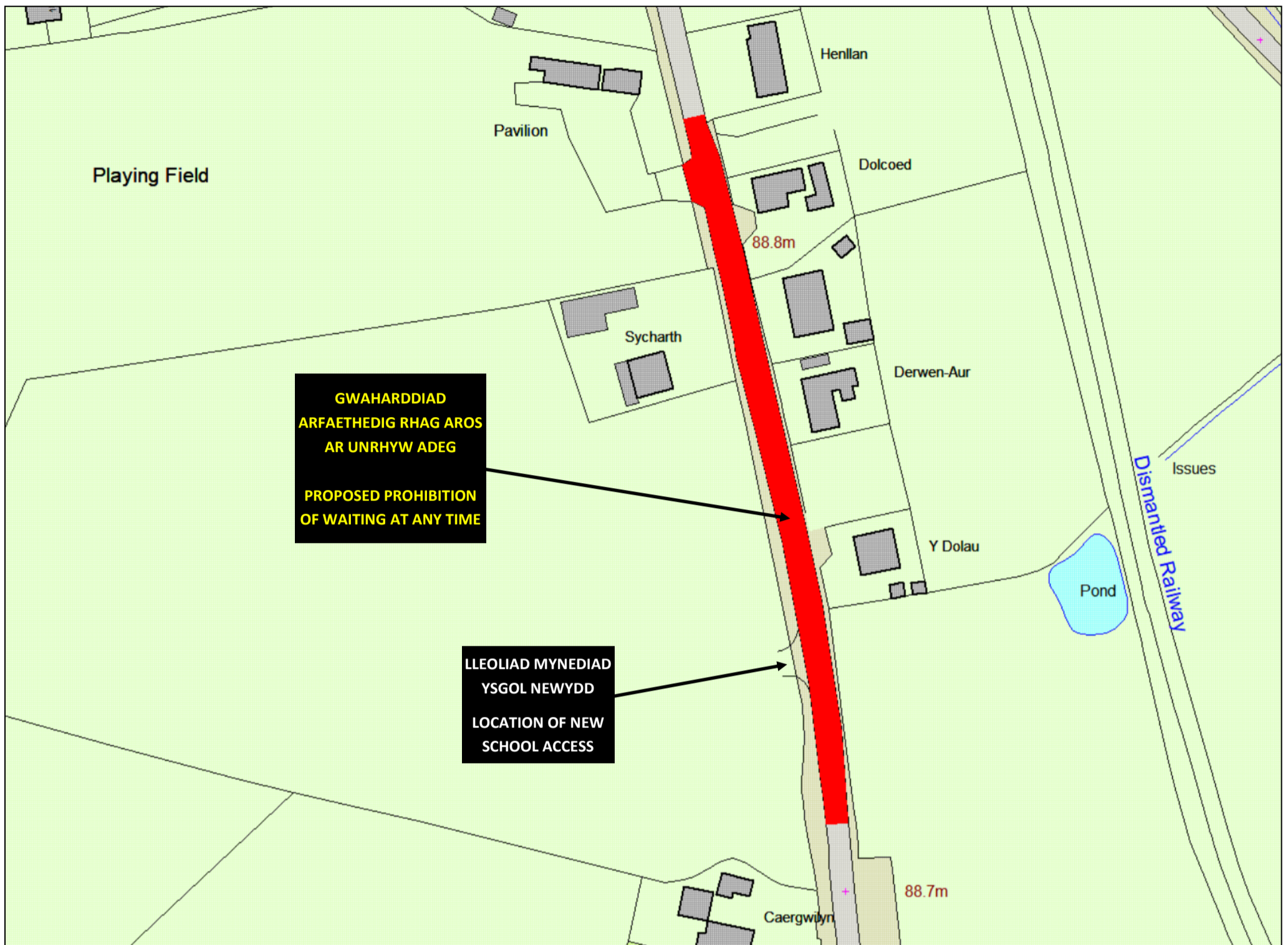

This will introduce a new Prohibition of Waiting At Any Time on both sides of the A482 from 1.75m north of the southern boundary of the property known as Henllan southwards to 8m south of the existing southern terminal point of the 20mph limit.
