### **Annex 1 - Mandatory conditions**

## Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

# Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
  - in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
  - (b) in respect of premises in relation to—
    - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
  - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
  - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

### Annex 2 - Conditions consistent with the operating Schedule

### **Promotion of Licensing Objectives:**

- a. General All four licensing objectives: Nothing entered in box.
- b. Prevention of Crime and Disorder: Alcohol is not available on the premises. Caretaker is employed to oversee private functions. Premises are alarmed and security lighting is installed. Access to 2 S.I.A. registered staff and 2<sup>nd</sup> when necessary.
- c. Public Safety: Fire exits are always kept clear. Extinguishers are checked annually. Annual Electrical Certificate and emergency lighting. Public liability insurance. Provision of No smoking signs. Fire proof blinds. Fire action notices. First aid kit. Maximum capacity: 120 seated, 200 standing as advised by fire authority.
- d. Prevention of Public Nuisance: No music permitted after 2400 HRS. Doors and windows kept closed when live music is on.
- e. Protection of Children from Harm: Children are always supervised by responsible adults. Any films shown will carry 2 classification by the British Film Board of Censors. Youth Club leaders have been vetted by Criminal records Bureau.
