Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence—
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) “security activity” means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

PREMISES SUBJECT TO EMBEDDED CONDITIONS CONVERTED UNDER LICENSING ACT 1964.

PROMOTION OF LICENSING OBJECTIVES:

- a. General – All four licensing objectives:** The four objectives will be to run a secure, safe, happy and lawful environment which the public can enjoy without causing problems or harm to visitors or neighbours.
- b. Prevention of Crime and Disorder:** The restaurant will not permit any drunken aggressive behaviour, any person causing a problem in this manner will be asked to leave and we will telephone the Police to ask for assistance in their removal if necessary. No drugs are permitted on the premises and staff will be advised to watch for any unusual behaviour, and will notify the Police of anything suspicious.
- c. Public Safety:** Gas, electrical, fire alarm and illuminated exit signs and fire equipment are checked regularly. First aid room supplied for appointed persons. Lighting on the outside of the building illuminates the car park for the safety of visitors and staff. Public liability insurance and employers liability is covered. Maximum Occupancy – Restaurant 52 persons at any one time. Remainder of Building 160 persons at any one time. Fire service letter of 2nd August 2005 confirms capacity.
- d. Prevention of Public Nuisance:** The restaurant is situated off the main road in a quiet location, but visitors will be asked to leave quietly and respect the neighbours by not making too much noise. There is ample parking so cars will not be parked on the main highway.
- e. Protection of Children from Harm:** All children will be accompanied by an adult, and only adults will be allowed to buy drinks of beer, porter or cider (including perry) for children over the age of 16 years with their meal.
