Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

General- all four licensing objectives

- A member of the committee shall be duty officer for any event/function held within the hall
- The hall is not Appling for an alcohol licence

The prevention of crime and disorder

• The range of activities applied for will not impact upon crime and disorder in the premises or in the vicinity. No alcohol will be sold during the normal activities. Any event during which alcohol will be sold will be dealt with by a temporary event notice by the hirer and not the hall committee please see attached conditions for ten which the hall committee will demand the hirer

Public safety

- The hall is newly purpose built and we will supply electrical safety certificate and emergency lighting certificates. All fire appliances are new and will be checked annually. The hall committee has a certificate of public liability insurance for all normal activities
- TEN applicants will require their own insurance

The prevention of public nuisance

- Normal activities in the hall will not cause any public nuisance and a member of the hall committee will be present at any function to oversee them
- TEN's hirers must supply SIA registered doorman at the rate of 1 for the first 100 persons and 1 per 100 persons after

The protection of children from harm

- Normally activities in the Hall will not in any shape or form endanger children or expose to harm
- For TEN all children must be accompanied by an adult
