

CEREDIGION COUNTY COUNCIL (OFF-STREET PARKING PLACES) ORDER 2025

Ceredigion County Council ("the Council") in exercise of its powers under Sections 32, 35 and of Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended ("the 1984 Act") and under the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:-

1. Commencement and Citation

This Order may be cited as Ceredigion County Council (Off-Street Parking Places) Order 2025 which shall come into operation on the 07/05/2025.

2. Interpretation

- (a) Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order, the:

Ceredigion County Council Ceredigion (Off-Street Parking Places) (Consolidation) Order 2012;

Ceredigion County Council Ceredigion (Off-Street Parking Places) (Consolidation) Order 2012 (Amendment Order 1) 2014; and

Ceredigion County Council Ceredigion (Off-Street Parking Places) (Consolidation) Order 2012 (Amendment Order 2) 2017.

shall be revoked on the date that this Order comes into operation.

- (b) Any reference in this Order to a numbered article is a reference to the Article bearing that number in this Order and any reference in this Order to:

- i) 'Schedule 1' is a reference to Schedule 1 of this Order
- ii) 'Schedule 2' is a reference to Schedule 2 of this Order
- iii) 'Schedule 3' is a reference to Schedule 3 of this Order
- iv) 'Schedule 4' is a reference to Schedule 4 of this Order

- (c) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-

"Caravanette" means a Vehicle which is constructed or adapted for sleeping;

"Charge Certificate" means the statement that the Penalty Charge has been increased by 50 per cent in accordance with Regulation 13 of The Civil Enforcement of Parking Contraventions (Penalty Charge Notices, Enforcement and Adjudication) (Wales) Regulations 2008;

"Charging Days" means the period specified in Column 4 of Schedule 1 in respect of which a charge is specified in Article 4 hereof;

"Charging Hours" means the period specified in Column 5 of the Schedule 1 hereto in respect of which a charge is specified in Article 4 hereof;

"Civil Enforcement Officer" means any officer of the Council or person who is authorised by the Council to supervise and control Vehicles in the Parking Places and enforce the provisions of this Order;

"the Council" means Ceredigion County Council;

"Disabled Persons Parking Bay" means a Parking Place which is provided for the leaving of a Vehicle which is being driven by a person eligible to use a "Disabled Persons Badge" or being used to transport at the time of parking a person eligible to use a "Disabled Persons Badge";

"Disabled Persons Badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000 and any amendments or re-enactment thereof;

"Driver" in relation to a Vehicle waiting in the Parking Place means the person driving the Vehicle at the time it was left in the Parking Place;

"Electric Vehicle" means a Vehicle that is powered entirely or partially by electricity and is capable of being charged from an external source;

"Electric Vehicle Charging Point" means a purpose-built unit designed specifically for charging Electric Vehicles;

"Expiry Time" means the time indicated on the Ticket or Parking Session by which the Vehicle must leave the Parking Place;

"Heavy Vehicles" means any Vehicle over 3.5t gross vehicle weight and includes Coaches and Buses;

"Invalid Carriage" has the same meaning as in Section 136(5) of the 1984 Act;

"Motor Car" has the same meaning as in Section 136(2) of the 1984 Act;

"Motor Cycle" has the same meaning as in Section 136(4) of the 1984 Act;

"Owner" in relation to a Vehicle means the person by whom such Vehicle is kept and used. It shall be presumed that the Owner was the person in whose name the Vehicle was, on the Relevant Date, registered under the Vehicle Excise and Registration Act 1994;

"Parking Bay" means any area of the Parking Place which is provided for the leaving of a Vehicle and indicated by markings on the surface of the Parking Place;

"Parking Disc" shall have the same meaning as in Regulation 8(5) of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) Regulations 2000;

"Parking Permit" and "Season Ticket" means a permit of any type and design, issued by the Council for such period as the Council shall determine from time to time on payment of

the appropriate charge as outlined in Schedule 1 and Schedule 3, for a Vehicle of a specific class and for specific Parking Place(s) and subject to such terms and conditions as determined by the Council from time to time;

"Parking Place" or "Car Park" means any area of land specified by name in Column 1 of Schedule 1 provided by the Council under Section 32(1) of the 1984 Act for use as a Parking Place;

"Parking Session" means a period of time for which parking has been paid for using a Pay by Phone Service;

"Parking Ticket Machine" means the apparatus provided by the Council at the Parking Place, for issuing Tickets indicating the payment of a charge, the date and time at which the charge was paid, and the Expiry Time;

"Pay and Display Ticket" or "Ticket" means a ticket issued by a Parking Ticket Machine located in the Parking Place in which the Vehicle has been left, or issued by a person nominated by the Council on payment of a Parking Charge, and valid only for the Vehicle for which it was purchased, for the Parking Place in which it was purchased and until the Expiry Time shown;

"Pay by Phone Service" or "Pay by Phone" means a cashless system of paying for or purchasing a Parking Session by use of a phone, internet, or other electronic means, provided by the Council;

"Penalty Charge" means a charge set in accordance with the provisions of Section 77 and Schedule 9 of the 2004 Act and in accordance the Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (Wales) Order 2013;

"Penalty Charge Notice" and "PCN" means a Penalty Charge Notice issued or served by a Civil Enforcement Officer or posted by or on behalf of the Council pursuant to the provisions of Section 78 of the 2004 Act and The Civil Enforcement of Parking Contraventions (Penalty Charge Notices, Enforcement and Adjudication) (Wales) Regulations 2008;

"Permit Holder Only" means a Parking Place for the use of designated Parking Permit holders only;

"Registered Keeper" means the person in whose name the Vehicle was on the Relevant Date registered under the Vehicle Excise and Registration Act 1994;

"Relevant Date" means the date upon which any Vehicle is or was parked in the Parking Place referred to in this Order or upon which any event occurs or occurred in breach of any of the provisions of this Order or to which this Order relates;

"Relevant Position" means in the case of a Vehicle fitted with a front windscreen, a position thereof with the front side facing forwards and clearly legible on the near side of and immediately behind the windscreen or, in the case of a Vehicle not fitted with a front windscreen, in an appropriate holder so that it is clearly legible and in a conspicuous position on the Vehicle;

“Trailer” means a trailer within the meaning of section 136(1) of the 1984 Act and shall include a caravan;

“Vehicle” means a mechanically propelled vehicle intended or adapted for use on roads for the purpose of transporting people or goods and, without prejudice to the generality of the foregoing shall include, but is not limited to, any Motor Car, Motorcycle, Caravanette, Bus, Coach, Heavy Vehicle or anything attached to, forming part of or being carried on the Vehicle and shall also mean any Caravan, Trailer, Boat or Boat Trailer whether attached to another Vehicle or not;

“Visitor” means a member of the public visiting the building. This does not include employees of Ceredigion County Council whether their work base is at the location or another location.

- (d) Any reference in this order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- (e) The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament and any reference to a statute (and whether to a particular statute or generally) shall be deemed to include reference to any future statute for the time being in force replacing or supplementing such statute and any regulations directions or consents made or granted thereunder and all provisions and conditions therein.

3. Use of a Parking Place

- (a) A Parking Places specified by name in Schedule 1 to this Order and whose extents are shown in the maps contained in Schedule 4 to this order, may be used, subject to the following provisions of this Order, as a Parking Place for such classes of Vehicle, in such position, on such days and during such hours as specified in Schedule 1 of this Order.
- (b) Where in Schedule 1 to this Order a Parking Place is described as available for Vehicles of a specified class or on specified days or during specified hours, the Driver shall not permit the Vehicle to wait in that Parking Place:-
 - i) Unless it is of a specified class or by prior arrangement;
 - ii) On days or during hours other than those specified;
 - iii) Where Parking Bays are delineated, in any position beyond the bay markings delineated by surface applied line markings, embedded contrasting-colour paving elements, barrier posts or other indication of a Parking Bay;
 - iv) In such a position as to obstruct access to the Parking Place, to obstruct the access roads within the Parking Place or obstruct the use of the Parking Place by others including, but not limited to, parking on verges, footways and hatched markings within the Parking Place.
- (c) No person shall permit a Vehicle to wait in a Parking Bay signed or marked on its surface as available for a disabled person unless that Vehicle is displaying in the windscreen a Disabled Person's Badge and that badge is displayed in the Relevant Position and

provided that the Vehicle is either driven or occupied as a passenger by the holder of the Disabled Persons Badge at the time of parking.

(d) No person shall permit a Vehicle to wait in a Parking Place or Parking Bay signed, or marked on its surface, as:

- i) available for Vehicles of a particular description,
- ii) available for Permit Holders Only,
- iii) a reserved Parking Bay

unless the Vehicle is of such description or has a valid Parking Permit or has been allocated a reserved Parking Bay.

(e) Irrespective of the period paid for, in accordance with Article 4(a) or 5(a) of this Order, an Electric Vehicle must:

- i) only use Parking Bays designated for Electric Vehicle Charging Bays whilst the Electric Vehicle is being charged by means of an Electric Vehicle Charging Point.
- ii) not park for longer than the maximum permitted time for parking in the Electric Vehicle Charging Bay as signed in the Parking Place.
- iii) not return to an Electric Vehicle Charging Bay within that same Parking Place within 3 hours of having left the Electric Vehicle Charging Bay.

(f) No person shall permit a Vehicle to wait in a Parking Place during Charging Hours without paying such charge or charges as are specified in Article 4(a) or 5(a) of this Order.

(g) No person shall permit a Vehicle to wait in a Parking Place during Charging Hours for a period in excess of the maximum period prescribed in Column 6 of Schedule 1 hereto and, when a Vehicle has left that Parking Place after waiting therein, no person shall within one hour after leaving the Vehicle permit it to wait again in that Parking Place during Charging Hours on that day.

(h) The Driver of a Vehicle using a Parking Place shall stop the engine as soon as the Vehicle is in position in the Parking Place and shall not start the engine except when about to change the position of the Vehicle in order to depart from the Parking Place.

(i) No person shall advertise a Vehicle as being for sale or use a Vehicle while it is in a Parking Place in connection with the sale of any article to persons in or near the Parking Place or in connection with the selling or offering for hire of his skill or services except those persons duly authorised in writing by the Council.

4. Charges for the use of a Parking Place

(a) Except where exempt by Article 7 of this order, the Driver of a Vehicle shall, on leaving it in a Parking Place, pay an hourly or daily charge (unless a valid Parking Permit is displayed in the Relevant Position) applicable to the Parking Place in accordance with the scale of charges set out in Schedule 1 and Schedule 2 of this Order.

- (b) Payment of the charge must be made immediately following the parking of the Vehicle in the said Parking Place and it must be in respect of the period (not being a period exceeding the maximum period for waiting in that Parking Place) during which the Vehicle is intended to be parked in that Parking Place.
- (c) The charge referred to in Article 4(a) shall be payable by either obtaining a Ticket from a Parking Ticket Machine located in the Parking Place where provided, or, where advertised as being available at the Parking Place, by purchasing a Parking Session through a Pay by Phone Service.
- (d) Any Ticket issued on payment of the charge in accordance with Article 4(a) at a Parking Ticket Machine (or otherwise required to be displayed by any provision of this Order) shall be placed in a conspicuous position on the Vehicle in respect of which it was issued and, shall be so displayed throughout the whole period that the Vehicle is in the Parking Place. For the purposes of this Article "a conspicuous position" shall mean:
 - i) in the case of a Vehicle fitted with a windscreen, a position on the inside of that windscreen or on the dashboard or fascia, with the front side of the Ticket up and fully legible from the outside of and to the right hand or Driver's side of the Vehicle.
 - ii) in the case of a Vehicle not fitted with a front windscreen, in an appropriate holder so that the Ticket is clearly legible in a conspicuous position on the Vehicle.
- (e) Where the parking of a Vehicle in any Parking Place is authorised by the payment of the charge in accordance with Article 4(a) such Vehicle shall not be left in the Parking Place beyond the Expiry Time of the Ticket or Parking Session.
- (f) Any Ticket or Parking Session purchased in payment of the charge in accordance with Article 4(a) shall be valid only for the Parking Place in for which it was purchased and for the Vehicle it was purchased for, and it is not transferable to any other Parking Place or Vehicle.
- (g) Any Ticket or Parking Session purchased shall only be valid on the day of issue except where the Ticket or Parking Session indicates that the time purchased extends into the following day's charging period.
- (h) The Driver of a Vehicle that is left in a Parking Place during the Charging Hours, shall pay such charges in accordance with the scale of charges set out in Schedule 1 and Schedule 2 of this Order for that Parking Place for each Parking Bay and / or part Parking Bay occupied. A Parking Bay partly occupied by the Driver's Vehicle shall incur a charge as if it were completely occupied.
- (i) When a Ticket(s) has been displayed on a Vehicle in accordance with Article 4(d), no person, not being the Driver of the Vehicle shall remove the Ticket(s) from the Vehicle unless authorised by the Driver to do so.
- (j) If at any time a Vehicle is left in a Parking Place either with no valid Ticket or Parking Permit displayed or there is no record of a valid Parking Session it shall be deemed that the charge has not been paid.
- (k) If at any time when a Vehicle is left during the Charging Hours in a Parking Place, and the nearest Parking Ticket Machine in that Parking Place is out of order, a Ticket shall be

obtained from another Parking Ticket Machine within the Parking Place (where provided) or, where advertised as being available at the Parking Place, by purchasing a Parking Session through a Pay by Phone Service.

- (l) If at any time when a Vehicle is left during the Charging Hours, a Pay by Phone Service is out of order, a Ticket shall be obtained from a Parking Ticket Machine within the Parking Place.
- (m) Where in a Parking Place there is no Parking Ticket Machine or Pay by Phone Service in operation, the charge referred to in Article 4(a) shall be payable on demand to a Civil Enforcement Officer or any other person authorised by the Council.
- (n) At Parking Places where there are Electric Vehicle Charging Points which entail a payment to the provider of the Electric Vehicle Charge Point, the Parking Charge in accordance with Article 4(a) of this order will be payable in addition to the payment made to the provider of the Electric Vehicle Charge Point.
- (o) Subject to the 1984 Act the Council reserves the right to change the scale of charges in Schedule 1 Column 7 to 8, in Schedule 2 and in Schedule 3 of this Order without further Order.
- (p) Subject to the 1984 Act the Council reserves the right to amend the entries in Schedule 1 Column 1 to 6 of this Order without further Order.

5. Parking Permits

- (a) The Owner of a Vehicle may on application to the Council purchase a Parking Permit at the appropriate fee as detailed in Schedule 1 and Schedule 3 of this Order for a Vehicle of a specific class and for a specific Parking Place or Parking Places subject to conditions determined by the Council.
- (b) The Driver shall abide by the terms stipulated by the Council for the use of the Parking Permit.
- (c) A Parking Permit is only valid in the Parking Place or Parking Places in respect of which it was issued and up to the date of expiry shown on the Parking Permit.
- (d) A Parking Permit remains the property of the Council and must be surrendered on request. In such instances where a refund fee is deemed appropriate by the Council this will be provided in accordance with the Council's policies.
- (e) The Driver of the Vehicle shall display the Parking Permit in the Relevant Position on the Vehicle in respect of which it was issued, at all times during which the Vehicle is left in the Parking Place.
- (f) Damaged or lost Parking Permits will be replaced on application to the Council and on payment of an administration fee. The damaged or lost Parking Permit will then become immediately invalid.

- (g) The holder of a Parking Permit on voluntarily surrendering the Parking Permit will not be entitled to a refund.

6. Contraventions and Penalty Charges Notices (PCN)

- (a) If there is any contravention of any of the provisions of this Order then a Penalty Charge shall be payable, for each calendar day of the said contravention, to the Council under and subject to the provisions hereinafter contained.
- (b) In the case of a Vehicle in respect of which a Penalty Charge may have been incurred it shall be the duty of a Civil Enforcement Officer authorised in that behalf by the Council to attach to the Vehicle in a conspicuous position, or hand to the Driver of such Vehicle, a PCN.
- (c) In the case of a Vehicle in respect of which a Penalty Charge may have been incurred a PCN may be issued by post by or on behalf of the Council if the Owner or Driver of the Vehicle drives the Vehicle away before the Civil Enforcement Officer has issued a PCN or the Civil Enforcement Officer has been prevented from issuing a PCN. Any PCN issued by post is deemed to have been served on the second working day after the day of posting.
- (d) The Penalty Charge shall be paid to the Council by the means specified on the PCN not later than the last day of the period of 28 days beginning with the date on which the notice was served.
- (e) In the event of payment being received by the Council as aforesaid not later than the last day of the period of 14 days beginning with the date on which the notice is served the amount of the said charge shall be reduced by 50%.
- (f) The Penalty Charge shall be increased by 50% on the issue of a Charge Certificate.
- (g) Payment of the Penalty Charge (whether or not the same is reduced under the provisions of 6(e)) will not exonerate any person from payment of any expenses recoverable in respect of the removal and disposal of the Vehicle pursuant to the provisions of Article 10 of this Order and any statutory provisions for the time being in force or from any claim to damages which the Council may have in respect of damage incurred in relation to the parking of the Vehicle howsoever arising.
- (h) A PCN fixed to a Vehicle in accordance with Article 6(b) shall not be removed or interfered with except by or under the authority of:
- i) the Owner, or person in charge, of the Vehicle.
 - ii) any person authorised by the Council.

7. Exemptions

(a) The following Vehicles left in the Parking Place shall be exempt from the payment of any charge applicable to Short and Long Stay Parking Places specified in Schedule 1 and Schedule 2 to this Order:

- i) A Vehicle displaying a valid Disabled Persons Badge.
- ii) An Invalid Carriage.

PROVIDED THAT such exemption shall apply only if the following conditions are complied with:

- iii) the Vehicle at the time of parking is either driven or occupied as a passenger by the holder of the Disabled Persons Badge, and
 - iv) the Disabled Persons Badge is displayed in the Relevant Position.
- (b) Livered Council Vehicles and any other Vehicle expressly authorised by the Council, used in pursuance of Council duties, shall be exempt from time limits, payment of charges and class restriction.
- (c) The provisions of this Order shall not apply to any Vehicle which is a Vehicle used for fire brigade, ambulance or police purposes in an emergency.

8. Closing and setting aside Parking Places

- (a) Notwithstanding the provisions of this Order the Council may, by notice displayed on or near any Parking Place, close such Parking Place or any part thereof for any period and no Driver of any Vehicle shall use the Parking Place or any part thereof when so closed without the written consent of the Council.
- (b) Nothing in this Order shall prevent the Council, by notice displayed at the Parking Place, from setting aside for a special use or for use only by specially authorised Vehicles or persons, of any part or parts of the Parking Place on all days or on certain days or during certain parts of certain days.
- (c) The Driver of a Vehicle shall not, except with and subject to the terms of any permission in writing from the Council, cause or permit the Vehicle:-
- i) to wait in the Parking Place or any part thereof at any time when the Parking Place or that part (as the case may be) has been closed under Article 8(a) of this Order;
 - ii) to wait in any part of the Parking Place at a time when that part has been set aside for special use by a specially authorised Vehicles or persons in accordance with Article 8(b) of this Order, unless the Vehicle or person is authorised.

9. Other provisions

- (a) No person shall, except with the permission of any person duly authorised by the Council, drive any Vehicle in a Parking Place other than for the purpose of leaving that Vehicle in the Parking Place in accordance with the provisions of this Order or for the purpose of departing from the Parking Place, and any person so doing are liable to prosecution.

(b) No person shall in a Parking Place wantonly shout or otherwise make any loud noise to the disturbance or annoyance of users of the Parking Place or residents of premises in the neighbourhood and any person so doing are liable to prosecution.

(c) No person shall in a Parking Place use any threatening, abusive or insulting language, gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned and any person so doing are liable to prosecution.

(d) No person shall use any part of a Parking Place or any Vehicle left in a Parking Place:-

- i) for sleeping or camping purposes;
- ii) for eating or cooking purposes except those persons duly authorised in writing by the Council;
- iii) for the purposes of servicing or washing any Vehicle or part thereof other than as is reasonably necessary to enable that Vehicle to depart from the Parking Place;
- iv) to erect or cause or permit to be erected any tent, booth, stand, building or other structure without the written consent of the Council; or
- v) light or cause or permit to be lit any fire;

and any person so doing are liable to prosecution.

(e) No person shall use a Parking Place as a means of passage for proceeding from one road to another road and any person so doing are liable to prosecution.

(f) No person shall, except with the permission of a person authorised by the Council, drive or permit to be driven any Vehicle in the Parking Place for any purpose other than the purpose of leaving that Vehicle in the Parking Place in accordance with the provisions of this Order or for the purpose of departing from the Parking Place.

(g) Where in a Parking Place signs are erected or surface markings are laid for the purpose of:

- i) indicating the entrance to or exit from the Parking Place; or
- ii) indicating that a Vehicle using the Parking Place shall proceed in a specified direction within the Parking Place;

no person shall drive or cause to be driven any Vehicle so that it enters the Parking Place otherwise than by an entrance, or leaves the Parking Place otherwise than by an exit so indicated or in a direction other than that specified as the case may be and any person so doing are liable to prosecution.

(h) The Driver of a Vehicle shall not drive or permit it to wait in any Parking Place unless:

- i) payment of Vehicle Excise Duty has been made in respect of the vehicle in accordance with the Vehicle Excise and Registration Act 1994, or
- ii) it exhibits in the prescribed manner trade plates issued in accordance with the Road Vehicles (Registration and Licensing) Regulations 2002 and the Vehicle Excise and Registration Act 1994, or

- iii) in accordance with any amendment or re-enactment thereof related to the above.
- (i) The Driver of a Vehicle shall not drive in or permit it to wait in a Parking Place unless there is in relation to the use of the Vehicle by the Driver such a current policy of insurance as complies with the requirements of Part VI of the Road Traffic Act 1998 and any amendment or re-enactment thereof.
- (j) Except with the written consent of the Council, no person shall use a Parking Place for the purpose of displaying or distributing advertising promotional or campaigning material and shall apply:-
 - i) to any person who engages in the distribution of advertising promotional or campaigning material in a Parking Place;
 - ii) to any person who engages any other person to distribute advertising promotional or campaigning material in a Parking Place;
 - iii) to any person whose goods, trade, business or other concerns receive publicity by the display of such advertising promotional or campaigning material;

provided that a person shall not be guilty of an offence by reason only that his goods, trade, business or other concerns are given publicity by the advertising material if he proves that it was displayed without his knowledge or consent.

- (k) No person shall in a Parking Place without the written consent of the Council (which may be given on such terms and conditions as it thinks fit) make any collection of money or articles for charitable or other purposes.

10. Removal of Vehicles

- (a) Subject to the provisions hereto, when a Vehicle is left in a Parking Place in contravention of any of the provisions of Articles 3, 4, 5, 7, 8 and 9 of this Order, a person authorised in that behalf by the Council may remove the Vehicle or arrange for it to be removed from that Parking Place or may alter or cause to be altered the position of the Vehicle in order that its position shall comply with that provision.
- (b) Any person removing or altering the position of a Vehicle by virtue of Article 10(a) may do so by towing or driving the Vehicle or in such other manner as they may think necessary and may take such measures in relation to the Vehicle as they may think necessary to enable him to remove it or alter its position as the case may be.
- (c) When a person authorised by the Council removes or makes arrangements for the removal of a Vehicle from a Parking Place by virtue of Article 10(a) they shall make such arrangements as may be reasonably necessary for the safe custody of the Vehicle. The Council shall not be liable for any loss or damage caused to the Vehicle or its contents as a result of its being moved within a Parking Place or removed from a Parking Place under the provision of this Order, except that resulting from the negligence of the Council or its contractors.
- (d) For the purpose of meeting the requirement of any emergency, a person authorised by the Council or a uniformed police officer may alter or cause to be altered the position of a

Vehicle in a Parking Place or remove or arrange for the removal of the Vehicle from that Parking Place.

- (e) Where a Vehicle is removed in accordance with the provisions of Article 10, the Council may recover the reasonable cost of such removal and storage from the Driver, Owner or other person claiming the Vehicle.
- (f) Any Vehicle which is or is liable to be removed from a Parking Place in pursuance of Article 10 and which appears to the Council to have been abandoned may be sold or otherwise disposed of by the manner provided by and subject to the provisions of the Refuse Disposal (Amenity) Act 1978 and may subject as aforesaid recover the expenses and charges from any person responsible as therein defined.

11. Immobilisation of Vehicles

- (a) When a Vehicle is left in a Parking Place in contravention of the provisions contained in Articles 3, 4, 5, 7, 8 and 9 of this Order a person authorised in that behalf by the Council may:
 - i) fix an immobilisation device to the Vehicle while it remains in the position in which it is found, or
 - ii) remove or make arrangements for the removal of the Vehicle from the Parking Place to another place and fix an immobilisation device to it in that other place.
- (b) On any occasion when an immobilisation device is fixed to a Vehicle in accordance with Article 11(a) of this Order, the person fixing the device shall also affix to the Vehicle a notice:
 - i) indicating that such a device has been fixed to the Vehicle and warning that no attempt should be made to drive it or otherwise put it in motion until it has been released from that device;
 - ii) specifying the steps to be taken in order to secure its release; and
 - iii) giving such other information as may be prescribed.
- (c) A Vehicle to which an immobilisation device has been fixed in accordance with Article 11(a) of this Order may only be released from that device by or under the direction of a person authorised in that behalf by the Council.
- (d) Subject to Article 11(b) above, a Vehicle to which an immobilisation device has been fixed in accordance with Article 11(a) of this Order shall be released from that device on payment in any manner specified in that notice affixed to the Vehicle under Article 11(b) of such charge in respect of the release as the Council may determine.
- (e) When an immobilisation device has been fixed to a Vehicle in accordance with Article 11(a) of this Order, no person, not being a person duly authorised by the Council, or under the direction of a person duly authorised by the Council, shall remove or attempt to remove the device from the Vehicle.
- (f) Where a notice has been attached to a Vehicle under Article 11(b) of this Order, no person, not being the Driver of the Vehicle, or a duly authorised representative of the Council, shall remove the notice from the Vehicle unless authorised by the Driver so to do.

12. Supervision of Parking Places

The Council does not undertake to supervise the Parking Places specified in Column 1 of Schedule 1 and Vehicles are parked entirely at the Owner's and/or Driver's risk and the Council will not accept any liability for any loss or damage howsoever caused either to the Vehicle or its contents or injury to persons arising from the use of the Parking Places save where such loss damage or injury arises as a result of the actions of the Council, its servants or its agents.

13. Validity

If a Court, the Welsh Government, the Traffic Penalties Tribunal or the Traffic Enforcement Centre declares any part of this Order to be invalid or unenforceable; such declaration shall not invalidate the remainder of the Order.
