## **Annex 1 - Mandatory conditions**

### **Mandatory conditions where licence authorises supply of alcohol**

- (1) No supply of alcohol may be made under the premises licence—
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### **Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:**

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
  - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
  - (b) in respect of premises in relation to—
    - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
  - (a) “security activity” means an activity to which paragraph 2(1)(a) of that Schedule applies, and
  - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

## **Annex 2 - Conditions consistent with the operating Schedule**

### **General- all four licensing objectives**

- The licensee and bar staff will have full knowledge of the Licensing Act 2003 and its requirements to comply with it

### **The prevention of crime and disorder**

- Supervision of behaviour of customers in and around the premises. Staff instructed not to admit or serve customers who behave in a drunk or disorderly fashion

### **Public safety**

- The hotel complies with Health and Safety precautions regulations which include fire alarms, extinguishers, smoke detectors, signs and fire certificate
- Overall maintenance checked regularly

### **The prevention of public nuisance**

- Supervision of unruly behaviour and excessive noise and consideration for neighbours and local property
- Steps taken to avoid disturbance when recorded music is being played

### **The protection of children from harm**

- Children allowed to eat in the restaurant accompanied by parents / guardians, and in to the function room for private parties
- Staff instructed that it is an offence to serve alcohol to under 18's and signs are posted at the bars prohibiting supply to under 18's
