Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to-
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

Promotion of Licensing Objectives

- a. General –This is a warehouse selling Spanish wine (and Food) online to customers, as well as providing storage for the goods sold in our shops and to our wholesale customers. Members of the public may only place orders online. Members of the public are not invited to the premises, or admitted to the warehouse. Alcohol is not on public display at the premises. Our terms and conditions clearly state that we will only sell alcohol to persons over 18. The designated premises Supervisor will not complete a sale to person who appears under 18 without proof of age.
- b. Prevention of crime and disorder. The Designated Premises Supervisor will not complete a sale to a member of the public who does not appear to be over 18years old without proof of age. The designated premises supervisor will accept a Validate card or a Portman Group card or a photo driving licence or other photo official document or a passport as proof of age.

c. Public Safety -

Members of the public are not invited to the premises to purchase alcohol. Members of the public place orders online for delivery by courier to their home address. The alcohol is stored out of public view. Alcohol is not placed on display for public view at the premises. The designated Premises Supervisor will not complete a sale to a member of the public who does not appear to be 18 years old without proof of age. The premises have a satisfactory electrical installation certificate. Inspections are carried out annually.

d. Prevention of Public Nuisance

Members of the public are not invited to the premises to purchase alcohol.

e. The protection of children from harm

The designated premises Supervisor will not complete a sale to a member of the public who does not appear to be over 18 years of age without proof of age. The designated premises Supervisor will accept a Validate card or a Portman Group card or a photo driving licence or other photo official document or a passport as proof of age Annex 3 - Conditions attached after a hearing by the licensing authority/ Mediation meeting
