Please check that you have the correct version of the form as, one is for Discount for Sale Properties approved under the Unitary Development Plan (UDP) (residency criteria is 10 continuous years in the last 20 years in Ceredigion) and the other is for Discount for Sale Properties approved under the Local Development Plan (LDP) (residency criteria is 5 continuous years any time in your lifetime in Ceredigion or it's adjoining Town/Community Councils)
