Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed
 - in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010

With effect from 6th April 2010

- 1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children –
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
- (i) the outcome of a race, competition or other event or process, or
 - (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

With effect from 1st October 2010

- **4**. (1) The premsies licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 5. The responsible person shall ensure that –
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is avilable to customers in the following measures
 - (i) beer or cider: ½ pint
 - (ii) gin, rum, vodka or whisky: 25ml or 35ml; and
 - (iii) still wine in a glass: 125ml; and
 - (b) customers are made aware of the avilability of these measures.

Annex 2 - Conditions consistent with the operating Schedule

- Dyfed Powys Police specifications CCTV, inside and at least one camera outside premises
- Persistently noisy customers are to be banned from premises
- Public liability insurance is to be in place
- Shop frontage and street (20 yards each way) to be swept and cleaned every 3hrs, and at closing time
- Prominent, clear and legible notices to be displayed at the exits, requesting the public to respect the needs of residents and to leave the premises quietly

Annex 3 - Conditions attached after a hearing by the licensing authority

Conditions

CCTV

 To be installed to cover the frontage/vicinity of the premises in accordance with Dyfed – Powys Police specification and to be operational on before 1st March 2006 – 1 camera inside, 1 camera outside

Door Supervisors

- From 25.04.06 on SIA registered door person to be employed at the premises from 11.00pm to termination of the licensable activity, daily.
- The SIA registered door person shall not be engaged in any activity which prevents him from carrying out his duties as a door supervisor.
- The SIA registered door persons must not consume alcohol before reporting for duty or during the course of his duty.
- The duty of the SA registered door person shall be supervise the conduct of customers in the premises and those queuing.
- Prior to 25.04.06 a steward shall engaged monitoring the conduct of customers in the premises and those queuing.

Conditions added as result of Appeal to Aberystwyth Magistrates Court on 6th September 2006.

- Condition 2 CCTV:-That the appellant shall reposition CCTV camera outside the Premises so as to provide a horizontal view of the frontage forthwith.
- Condition 3 Documents:- That the appellant do produce the following document to the Licensing Authority forthwith – Public Liability Insurance Certificate.
- Condition 4 Door Supervision:- An SIA registered doorperson to be installed at the premises during the licensable activities on the following dates:
 - i. Student Ball annually (Whichever day of the week upon which it may fall)
 - ii. Every Saturday (During University term time only) from 11pm to the end of the licensable activity.
- 4. Condition 9 Cleaning:- The Appellant shall clean and clear the shop frontage and the street up to the corner of Northgate Street and Pound Place (up to and including the gutter) from 11pm daily to the end of licensable activities, every three hours and at closing time. The Appellant shall remove all wastes of any type.
- 5. The opening hours of the premises to be displayed in a prominent place at the premises, such signage to be in place within 7 days.

6.	6. The doors of the Premises to be closed at the end of the licensable activity and only persons already inside the premises to be served.
