Dear Mr Williams

I have made an application to Ceredigion County Council to downgrade the Right of Way that is shown on the Definitive Map as route 30/38 and I am required under the Wildlife and Countryside Act to serve notice on you as land owner. The route that is subject of my application and identified as 30/38 are the old and private farm tracs, from Bryneiddwen to the Common, and from Bryneiddwen down tothat part of the common known as the Llyn Eiddwen Special Reserve. (see enclosed plan, Shaded Pink). Clearly these private farm tracks were wrongly registered as PROW by Aberystwyth Rural District Council in or around 1966, during what we have discovered was a flawed registration process.

I am applying for the downgrading of this path as it has recently been re-classified as a Bridleway a class of use that will severely impair on my use of the land. Horses have always grazed the land and I have been encouraged, for ecological reasons as part of my Glastir agreement, to continue with this practicae. Anyone riding through will be at risk should there be a stallion or young colt amongst my horses.

I am sure you will recall our efforts to object to the re-classification process by Dyfed County Council during 1990-1991, a process that was not completed by that Authority. Our offer to allow a footpath across the land was not taken up then and was not even considered by Ceredigion County Council that chose to refer the matter to the Planning Inspectorate during 2014.

The track was for farm use only, has never been used by the public and the gates have been locked for 40 years on Council Officers advice following trespass by a group of hippies who had set up a camp on the Common.
