Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010

With effect from 6th April 2010

- 1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children –
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise):
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less:
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
- (i) the outcome of a race, competition or other event or process, or
 - (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

With effect from 1st October 2010

- **4**. (1) The premsies licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 5. The responsible person shall ensure that –
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is avilable to customers in the following measures
 - (i) beer or cider: ½ pint
 - (ii) gin, rum, vodka or whisky: 25ml or 35ml; and
 - (iii) still wine in a glass: 125ml; and
 - (b) customers are made aware of the avilability of these measures.

Annex 2 - Conditions consistent with the operating Schedule

The prevention of crime and disorder

Door Supervisors

- Door persons will be in place on Friday and Saturday from when the regulated entertainment begins until regulated entertainment stops as follows;
 SIA for the front door
 - 2 SIA for inside the premises
 - Total of 3 door persons
- 2. Door supervisors will carry proof or registration
- 3. Door supervisors will be authorised to refused admission to customers who are either excluded individuals or drunk and/or disorderly, or suspected of carrying illegal drugs or offensive weapons
- 4. Door supervisors will ensure that queuing for admission takes place in an orderly fashion
- 5. Door supervisors will be clearly identified as security personnel
- 6. Door supervisors will sign a register maintained by applicants recording the date and time which each door supervisor commences a period of duty
- 7. The applicants shall record in respect of each door supervisor whether that person is am employee of the licensee, and if not, the name of the person or company or agency by whom the door supervisor is employed, or through whom services of the door supervisor are engaged
- 8. The applicants shall ensure that the register may be inspected by the local authority and by the police, and records shall be kept for a minimum period of 3 years
- Door supervisors shall not be permitted to consume intoxicating liquor or other intoxicants during any period of duty at the premise
- 10. Door supervisors will be authorised to conduct searches of prospective customers as a condition of entry
- 11. Any necessary search of a female customer will be conducted by a female member of staff under the supervision of a door supervisor registered with the SIA
- 12. Door supervisors will encourage customers to leave the premises in a quiet and orderly fashion, and to remind customers who refuse to comply that they may be barred from the premises if they behave in a disorderly or noisy fashion

CCTV

 3 CCTV cameras in the stable bar, 4 CCTV cameras in the front or lounge bar, and 1 CCTV camera outside the premises will be installed and working satisfactorily

- CCTV digital recordings of any incident of serious disorderly will be maintained for a period of 31 days and will be made available to the police on request
- A Notice will be displayed at the entrance of the premises advising that CCTV cameras are in operation on the premises

Pub Watch

- 1. The Applicants shall be members of the Pub Watch Scheme
- 2. Notices will be displayed on the premises advising that the applicants are members of the Pub Watch

Bottles and Glasses

- 1. Customers carrying open or sealed bottles or glasses obtained from other premises are not admitted to the premises
- 2. Customers are not permitted to take open containers of alcoholic or soft drinks from the premises
- 3. Regular sweeps are made to remove all bottles and glasses from the public areas as soon as they are finished with or empty

Capacity Limits

- 1. A capacity limit of 299 persons for the premise including the applicants and employed staff shall be maintained to prevent overcrowding which could lead to disorder
- Door supervisors are supplied with and use hand-held counters to monitor the numbers of persons on and admitted to the premises

Drinks promotions

All-inclusive nights other irresponsible drinks promotions shall not be permitted

Drugs

- 1. The premises displays signs indicating to customers that the use of controlled drugs on the premises will be reported to the police
- Staff and door supervisors are authorised to refuse admission to any persons suspected of carrying illegal drugs
- 3. A secure facility to store controlled drugs seized or found on the premises prior to collection by the police is available

Notices

 The premises displays posters warning customers about their behaviour and use of controlled drugs, and advising customers that they could be barred from all licensed premises in the vicinity.

Public Safety

First Aid

Adequate and appropriate first aid equipment and materials are available on the premises behind each of the bar service areas

The prevention of public nuisance

Noise and Vibration

- 1. Noise limiters are fitted to the in-house disco amplification equipment, and have been set by the applicants in accordance with the limits advised by the Environmental Health Departments
- 2. Prominent, clear and legible notices are displayed at the exit requesting customers to respect the needs of local residents and to leave the premises and the area quietly
- 3. The applicants do not permit the use of explosives, pyrotechnics, fireworks, etc, which could cause disturbance in surrounding areas, are not permitted to be used on the premises
- 4. The placing of bottles into receptacles outside the premises is only permitted before 18:00 hours to minimise disturbance to nearby properties
- 5. From 02:00 to 04:00 recorded music will be reduced in volume, and will be discernibly quieter
- The designated premises supervisor will make regular check outside the premises for noise levels emanating from the premises between the hours of 00:00 to 04:00

Light Pollution

The premises will not have flashing or bright lights on or outside the premises, so as not to cause a nuisance to nearby properties

The protection of children from harm

- 1. Persons under 16 years of age are not admitted to the premises after 21:00 hours
- Children under 16 years of age may be admitted to the premises prior to 21:00 hours provided they are accompanied and supervised by a responsible adult over 18 years of age

- For the purpose of the admission of children under 16 years of age to the premises, accompanied/supervised means present in the same area of the premises, as a child being accompanied and under supervision
- 4. Children and young person under 16 years of age present on the premises are required to leave the premises by 21:00 hours
- 5. The applicants will not employ persons under the age of 16years on the premises at all

Age Restriction

The Applicants and their staff operate a Challenge 21 policy in respect of alcohol sales

Child Welfare

The applicants and their staff will be vigilant in respect of general child welfare issues, and will report concerns initially to the designated premises supervisor in appropriate circumstances who if he is satisfied that the report should be made will make a report to the responsible authorities.

Annex 3 - Conditions attached after a hearing by the licensing authority

Matters Agreed.

- 1. The areas of the premises marked 'pavement areas' on the plan attached at Annex 4 may only be used when the premises has the benefit of a licence issued under S115C, 115E, 115F and 115K of Part A of the Highways Act 1980 and in strict compliance with the terms and conditions of any such licence.
- 2. Tables and Chairs placed within the pavement areas must be removed at 21:00 hours daily from outside the premises
