Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

a) General

We aim to maintain a clean and safe environment not only for ourselves but also for staff members and general public.

b) The prevention of crime and disorder

We have CCTV on at all times which we will provide to the Police if and when needed. Those showing inappropriate behaviour will be asked to leave.

A CCTC system to be installed and operational to be upgraded so as to comply with Heddlu Dyfed-Powys Police specifications, as set out in document in hearing pack (see Annex 3) and also in accordance with the Edryd Jenkins quotation dated the 10th January 2013 (see Annex 3) to include internal and external dome cameras. Such system to be in place and operational before commencement of the licence.

SIA registered doorperson to be employed at the premises on Friday and Saturday from 11:00pm to the terminal hour of licensable activity

c) Public safety

All spill/rubbish are to be cleaned up as soon as possible. And all risk will be minimised with signs and there will be a premises insurance for public liability.

d) The prevention of public nuisance

People will be asked to leave in a quiet and orderly manner.

Drunk/disorderly people will be asked to leave.

Prominent, clear and legible bilingual notices to be displayed at the exit requiring the public to respect the needs of the local residents and leave the premises and the area quietly. The notices to contain the following form of words or similar:-

"Dylech barchu eich cymdogion. Cofiwch y gall niwsans sŵn ac ymddygiad gwrth-gymdeithasol effeithio ar drigolion lleol. Gwnewch cyn lleied o sŵn â phosibl wrth adael yr adeilad a'r ardal o gwmpas."

"Please respect the needs of our neighbours. Remember local residents can be affected by anti-social behaviour. Keep the noise to a minimum when leaving these premises, and exit the area quietly."

The Applicant to clean outside the premises every three hours and at close of business, such area to include the streets, gutter and the frontage of the premises occupied by Mr. Les Jones (No 9 Pier Street) including a distance of 20 yards left and right.

That the Applicant provides effective sound-proofing at ceiling level at No 9 Pier Street and on the adjoining wall with No 9 Pier Street.

e) The protection of children from harm

No children under the age of 16 years will be allowed on premises after 11pm unless they are accompanied by an adult.

Conditions

The Applicant's Operating Schedule to be incorporated into the licence, save as amended below:

- A CCTC system to be installed and operational to be upgraded so as to comply with Heddlu Dyfed-Powys Police specifications, as set out in document in hearing pack and also in accordance with the Edryd Jenkins quotation dated the 10th January 2013 to include internal and external dome cameras. Such system to be in place and operational before commencement of the licence.
- All footage must be of good quality and of a minimum performance capability sufficient to identify individuals
- It must be in colour
- All footage during the duration of the licensable activities to be retained for a period of 30 days
- The CCTV system must operate continuously, and if a defect arises the police must be informed and immediate arrangements must be made to rectify the fault
- All footage must <u>on demand</u> be made available to a police officer for viewing and a copy of that footage made immediately available to a police officer.
- At all times during the period of operation of the premises there must be a competent person on the premises capable of reply and be able to

- undertake the export of recordings quickly onto a removable storage medium. Only VHS tape, CD or DVD format is acceptable to the police. The master copy will be available to the police on demand.
- The system must incorporate a means of transferring images from the hard drive to a format that can be played back on any Microsoft Windows compatible computer. The application software required to launch and view recorded images must either be included as part of the standard Microsoft operating system installed or be installed to the recorded media when the data is copied to that media.
- The whole of the licensed area with entry and exit areas must be covered by cameras, and there must not be any hidden or obscured areas. This will deal with issues which have risen outside the premises when customers have been arriving or leaving.
- Sound recording must be available within the area of CCTV cameras around the till. This is to secure evidence of any hate crime which may occur.

- Prominent, clear and legible bilingual notices to be displayed at the exit requiring the public to respect the needs of the local residents and leave the premises and the area quietly. The notices to contain the following form of words or similar:-

- 3. SIA registered doorperson to be employed at the premises on Friday and Saturday from 11:00pm to the terminal hour of licensable activity.
- 4. The Applicant to clean outside the premises every three hours and at close of business, such area to include the streets, gutter and the frontage of the premises occupied by Mr. Les Jones (No 9 Pier Street) including a distance of 20 yards left and right.
- 5. The Applicant to submit a plan to the Police and Fire Authority showing the location of fire detection and fire equipment, within 14 days from the commencement of the licence.
