Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

Promotion of Licensing Objectives

- a. General All four licensing objectives: We are a small shop and do not employ any staff at present. However we will ensure that we comply with the requirements of the Licensing Act 2003 and any future employees receive instructions.
- b. The Prevention of Crime and Disorder: We will not serve anyone who is or appears drunk or is behaving in a disorderly manner. If such an event occurs then the Police will be called if necessary. The premises is secured by good quality locks.
- c. Public Safety: We have public liability insurance and will advise our insurers of our operating schedule. We have a first aid kit on the premises.
- d. The Prevention of Public Nuisance: Our opening hours are not excessive. As stated at b above we will not tolerate any unacceptable behaviour.
- e. The Protection of Children from Harm: We have a policy to ensure that under age customers are not sold alcohol or tobacco. We will challenge anyone who appears to be under 21 and demand ID. The only ID we will accept will be photographic, e.g. driving licence, passport, pass or valid logoed cards. If in any doubt we will not serve.
