Cabinet resolved:

DECISION:

"C50 - To approve the proposal to commence the statutory consultation process to cease to maintain the provision at Ysgol Craig yr Wylfa with effect from 31 August 2025.

- C51 To approve the proposal to commence the statutory consultation process to cease to maintain the provision at Ysgol Llanfihangel y Creuddyn with effect from 31 August 2025.
- C52 To approve the proposal to commence the statutory consultation process to cease to maintain the provision at Ysgol Llangwyryfon with effect from 31 August 2025.
- C53 To approve the proposal to commence the statutory consultation process to cease to maintain the provision at Ysgol Syr John Rhys with effect from 31 August 2025."

Following the Cabinet decision, Statutory Consultation papers were prepared.

The formal consultation for Ysgol Craig yr Wylfa, Ysgol Llangwyryfon and Ysgol Syr John Rhys commenced on 14/10/24, and is due to end on 3/12/2024. The formal Consultation for Ysgol Llanfihangel y Creuddyn commenced on 5/11/24 and is due to end on 16/12/24.

Current Position

On 19 November 2024, the Authority received a formal challenge to the decision made on 3/9/2024 to undertake a statutory consultation with a proposed closure date of 31/8/25 which is deemed not feasible and therefore needs to re-consider the decision made on that date.

The Authority needs to consider whether to amend the decision of 3/9/2024 to provide that the current process be an informal consultation period to gather further information, rather than that of a statutory consultation.

The responses received during the informal consultation period will be analysed, and any future statutory consultation proposals and assessments will be comprehensively prepared and completed.

It is accepted that the current timeline for the reorganisation process is not achievable, and therefore the 3/9/24 decision is not deemed to be capable of implementation.

It is proposed therefore to treat the ongoing statutory consultation (14/10/2024 to 3/12/24 for Ysgol Craig yr Wylfa, Ysgol Llangwyryfon and Ysgol Syr John Rhys; and 5/11/24 to 16/12/24 for Ysgol Llanfihangel y Creuddyn) as an informal consultation on the future of the schools and any reorganisation.

A further report will then be presented to Cabinet. After considering the response to the informal consultation, any proposals will be presented to Cabinet in due course.
