Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to-
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

Promotion of Licensing Objectives:

a) General – all four licensing objectives

- Trained operational staff in attendance whenever venue is open for licensable activities;
- Provision of additional 24 hour Campus Security Service response and support;
- Provision of trained and qualified management staff;
- Well lit premises, entrances and exteriors.

b) The prevention of crime and disorder

As "General" above.

c) Public safety

As "General" above plus:

- Emergency lighting and exit signage in place to statutory standard;
- Electrical testing, progressive and reactive maintenance work carried out to statutory standards and timescales;
- Provision of Fire Safety and First Aid trained staff;
- Provision of drinking water/soft drinks free of charge at all times when alcohol is provided.

d) The prevention of public nuisance

As "General" above.

- The International Politics Building is a detached building, wholly owned/controlled by UWA;
- The risk of noise, vibration and light pollution (coupled with type of use) is minimal.

e) The protection of children from harm

As "General" above plus:

- Policy of no under 18's allowed unaccompanied into premises during licensable activities;
- U18's only permitted access at controlled private functions;
- Practice of employing proof of age scheme as necessary including Student Union ID Cards;
- Refusal to serve alcohol to anyone who is or suspected of being under 18 years of age.
